OFFICIAL RULES

NO PURCHASE OR DONATION IS NECESSARY TO ENTER OR WIN. A PURCHASE OR DONATION DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Eligibility: This Contest is open only to those who have epilepsy, seizures or a seizure disorder (a doctor's attestation will be required) and who are 18 years of age as of the date of entry. A caretaker of a person with seizures under the age of 18 may enter on their behalf. The contest is only open to legal residents of GEORGIA, and is void where prohibited by law. Employees, Board of Directors and Professional Advisory Board Members of the Epilepsy Foundation of Georgia (also known as EFGA), its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the contest. The contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

Only qualified will be accepted. Once the initial entries have been received, EFGA will review and select 5 (five) finalists to move onto the next round. The Second Round will consist of a social media contest, in which EFGA will post the finalist's story on Facebook and Instagram, whoever receives the most likes beginning Thursday, January 19, 2017 at Noon through Monday, January 23, 2017 at Noon will be the winner.
- 4. How to Enter: For First Round entries, the Contestant must enter by submitting a 140 character tweet to the Twitter handle @EpilepsyGA stating why they should be chosen to win this context. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize.
